THE FOLLOWING CONDITIONS ARE REQUIRED FOR ANY ASSOCIATION TO PROVIDE IF THEY WISH TO HOST A COUNTRY CHAMPIONSHIP.

These have been compiled from many years' experience being involved in these events. It is also a fact that the Country event attracts more teams than the State event and has to be carried out in a shorter playing time.

- 1, A MINIMUM of 9 pitches must be provided. (8 plus pitches with lights will not do it. To make up a loss of 12-13 time slots will require 6 pitches with lights.)
- 2 It is preferable that all pitches must be in 1 location but if not this will be addressed later.
- 3, First aid facilities with ambulance in attendance. Tent and trestle table for them to treat injuries
- 4, Food and toilet facilities for the convenience of players and spectators. Gino will attend with coffee and ice cream and pay the association to be in attendance.
- 5, Power for Gino and Sports Centre
- 6, Written quotation for a 9m x 6m covered, waterproof and secured tent to be erected and dismantled for Sports Centre.
- 7, 9 trestle tables for Sports Centre use.
- 8, Erect all goals, nets, corner flags and mark pitches. (SAJSA have 8 sets of goals, nets and flags that can be borrowed free of charge but host pays for delivery and return)
- 9, Location with power and facility to take registrations, compile fixture results and display same.
- 10, Suitable venue to hold SAJSA meeting with delegates.
- 11 Location, PA system and 2 trestle tables to hold presentation.
- 12, Any Association requiring a tent for the event can have it arranged by host but the Association requiring it is responsible for paying the cost.
- 13, 30 bottles of water per team entered and a minimum of 2 bottles per day for all referees. Team water can be substituted with oranges but referees water remains.

14. Details and locations of suitable accommodation to cater for all people that will be attending within a reasonable distance.

REFEREES

1. Any referees that are needed from Adelaide, the host Association is responsible for paying, all accommodation, meals, (lunch and tea) and travelling expenses.
2. 2 tents for use during the day. 1 male and 1 female.
3. 10 chairs in each tent and 1 trestle table in one for match card use.
4. Referee co-ordinator to collect match cards and supply to SAJSA office. (required if a co-ordinator from FFSA cannot attend)
5. Refreshments as previously noted.

IF AN ASSOCIATION HAS TO USE MORE THAN ONE VENUE THEN THE FOLLOWING MUST ALSO BE PROVIDED AT ALL VENUES AWAY FROM MAIN VENUE.

1. At least 1 food outlet for player and spectator use. (SAJSA will endeavour to provide the coffee van)
2. Toilet facilities for the players and spectators.
3. 240 volt power for use
4. Changing tent/room for referees with 10 chairs and 1 table.
5. First aid facilities via a sports trainer or similar to treat any injuries.
6. Person to collect match cards after every round and phone the results to the SAJSA office. This person also to collect the cards after 3 rounds and take to the office and collect updated fixture results to post at venue.
7. Make sure match cards and refreshments are taken to the venue for use.
8. Separate venues must be no more than 2 kilometres from main venue for convenience of players, parents and officials.

SAJSA WILL PROVIDE

1. All match cards filled out
2. Trophies, Plaques and Medallions for all winners and runners up.
3. All match balls for the event.
4. All programmes for every team
5. Pay all referee and assistant referee match fees.
6. Pennants for every player
7. When the host Association cannot provide enough referees to cover the event, then the money SAJSA will pay the host Association is \$220 per team entered, as passed at the General meeting in Strathalbyn September 2017.

FINALLY,

THE ONLY VIABLE ALTERNATIVES TO ABOVE, ENABLING AN ASSOCIATION TO HOST A COUNTRY EVENT IF THEY CANNOT COMPLY, IS TO HOLD THE EVENT OVER 3 DAYS, OR OVER 2 CONCURRENT WEEKENDS, BY SPLITTING THE AGE GROUPS.
